ARCO RIGHTS APPLICATION

Access: The holders of personal data have the right to access their personal information that is in the possession of third parties, in order to know what they are and the state in which they are found, that is, if it is correct and updated, or to know for what purposes it is used.

Rectification: The holders of personal data have the right to rectify their personal information, when it turns out to be incomplete or inaccurate.

Cancellation: The holders of personal data may request their deletion when they consider that they are not being used or processed in accordance with the purposes for which they were provided. The elimination of personal data does not always proceed immediately, since sometimes it is necessary to preserve them for legal, liability or contractual purposes. When this happens, the blocking proceeds and during it the personal data may not be used for any purpose, and once concluded they must be eliminated.

Opposition, revocation or limitation of use: The holders of the personal data may oppose or withdraw their consent for the processing of their personal data for all the secondary purposes that they have consented to or only for some of them. The opposition of the consent will not proceed in those cases in which the processing of personal information is necessary for the fulfillment of a legal or contractual obligation.
